

**PUBLIC HEARING FOR THE HIALEAH HOUSING AUTHORITY FY 2021  
PUBLIC HOUSING AGENCY ANNUAL PLAN, ITS CAPITAL FUND FY  
2021 ANNUAL STATEMENT AND ITS 5 YEAR ACTION PLAN**

The Hialeah Housing Authority has developed its FY 2021 Public Housing Agency Annual Plan, its Capital Fund FY 2021 Annual Statement and its 5 Year Action Plan in Accordance with the Quality Housing and Work Responsibility Act of 1998. The Plan provides a ready source for interested parties to locate PHA policies, rules, and requirements concerning the PHA's operations and programs serving the needs of low-income and very low-income families in the City of Hialeah.

The Annual Plan, Supporting Documents, Revised Administrative Plan and Admissions and Occupancy Policies as well as the Capital Fund documents will be available for public review and comment starting September 4, 2020 at the Hialeah Housing Authority, 75 East 6<sup>th</sup> Street, Hialeah, Florida, between 8:30 AM to 5:00 PM, Monday through Friday, during normal business hours as well as published on the Authority's website-hialeahhousing.org

On October 27, 2020, at 6:00 p.m., the Hialeah Housing Authority ("HHA") will hold a Virtual Public Hearing ("VPH") to gather public input for the Hialeah Housing Authority Annual Plan 2021, the Capital Fund FY 2021 Annual Statement and its 5 Year Action Plan, to be submitted to US Department of Housing and Urban Development ("HUD").
